**1.0 REQUEST FOR NIAMEY, NIGER FIELD OFFICE CPC APPLICATIONS**

This is a combined synopsis/solicitation for commercial items prepared in accordance with the format in FAR Subpart 13, as supplemented with additional information included in this notice. This announcement constitutes the only solicitation; resumes are being requested and a written solicitation will not be issued.

**2.0 EVALUATION OF APPLICATIONS**

**2.1 QUALIFICATIONS**

Applicants qualified for this position shall demonstrate, in the documents/information submitted and through the Application Evaluation Process described in Section 2.2, the ability to provide the services as described in the attached scope of work (SOW) by the evaluation of the following criteria:

**EVALUATION CRITERION 1 – REQUIRED TECHNICAL CAPABILITY**

1. A bachelor's degree from an accredited university in business administration; management; public administration; finance; accounting; agriculture, community or rural development; economics; or a related field.
2. High level of motivation, personal commitment, and ethical standards.
3. Fluency in spoken and written English.
4. High level of fluency in French and at least one major national language.
5. Willingness to travel extensively throughout Niger.
6. Demonstrated ability to operate independently in high visibility, high-pressure environments and operate in complex office environment, emergency and/or political crisis situations with minimal supervision;
7. Knowledge of grant management or commercial/micro-lending; and
8. Knowledge of community needs assessment, mobilization, community enterprises participatory development, and/or monitoring the implementation of an assistance activity under a grant or cooperative agreement.

**PREFERRED BUT NOT REQUIRED TECHNICAL CAPABILITY**

1. Knowledge of and commitment to USADF mission goals and priorities.
2. Knowledge or experience with community needs assessments, mobilization.

**EVALUATION CRITERION 2 – REQUIRED EXPERIENCE**

1. Experience working with marginalized groups and/or community-based enterprises.
2. Experience managing client relationships, especially in a grants management, banking, business development, or international development context.
3. Experience with or education related to financial management/accounting.
4. Experience auditing, monitoring, or evaluating international development programs.
5. Three years of professional experience in business development, finance, banking, monitoring auditing, and evaluation, and/or management of international development programs.

**PREFERRED BUT NOT REQUIRED EXPERIENCE**

1. Professional experience in Niger.

2. Experience working with international donors.
3. Experience with grant management or commercial/micro lending.
4. Experience with participatory development methods.

### **EVALUATION CRITERION 3 – PAST PERFORMANCE**

- A list of three (3) references with contact information (telephone and if available, email)

### **2.2 APPLICANT EVALUATION PROCESS**

The above criteria described in Section 2.1 will be evaluated for each applicant in the following three (3) phases. Evaluation Factors are used to determine the competitive ranking of qualified applicants in comparison to other applicants. The factors are listed in priority order from highest to least. Award shall be made based on the best overall value to the Government. All evaluation factors other than cost or price, when combined, are significantly more important than price.

**Phase I - Initial Review:** The highest scoring applicants who have provided all the required documents/information and demonstrate, in written form, the capability to provide the services as described in the SOW and possess the requirements as listed in Section 2.1 will be invited to Phase II.

**Phase II - Interview:** The interview will be scheduled with the applicant(s) and will take place at the USADF office in Niamey, Niger or by telephone with Washington, District of Columbia (D.C.) USADF staff. The interview will evaluate the applicant's job-related knowledge and communication skills.

During the interview, the applicant(s) will be evaluated on their ability to communicate effectively in the English language, as well as his/her ability to communicate fluently in French and in a major local language.

In addition, reference checks will be conducted. An applicant must not receive any negative past performance responses to receive further consideration for contract award.

### **3.0 SALARY**

The salary offered to the successful applicant, chosen after completion of Phase II, will be determined from the assessment of the applicant from all three phases of the evaluation process, particularly considering:

- qualifications,
- salary and work history, and
- experience

The actual salary will be negotiated within the monthly pay range depending on qualifications, salary and work history, experience, and educational background. The amount offered for the Base Period compensation will not exceed CFA 13,631,200. Salaries over and above the top of the pay range will not be entertained or negotiated.

### **4.0 AWARD**

An offer for award will be made to the highest rated applicant evaluated in Phase II. If the offer is not accepted, the Government reserves the right, without further discussion, to move onto the next highest rated applicant.

The selected applicant must pass a basic background security screening through the United States Embassy prior to the start of work under contract and a medical examination within 60 calendar days of contract award. The medical examination documentation shall be provided to USADF Regional Director.

## **SCOPE OF WORK (SOW)**

### **1.0 BACKGROUND**

The United States African Development Foundation (USADF) is an agency of the United States Government. USADF supports private businesses, farmers' cooperatives, associations, and various community-based organizations, especially those serving marginalized peoples, engaged in economic and social development activities.

The Foundation started its funding activities in Niger in 1986. USADF's office in Niamey provides on-going support to projects that have been financed and also continues to identify viable local community development and small and medium-sized enterprises that show potential to create employment opportunities, generate incomes and have broad social impact beyond the project activity.

The following seven key principles serve as guidelines for all USADF management planning, budgeting, and evaluation activities. These priorities help ensure USADF stays true to ITS MISSION.

- (1) Model HIGH EFFECTIVENESS AND LOW OVERHEAD operations.
- (2) Focus program activities on MARGINALIZED COMMUNITIES in Africa.
- (3) Invest in African ideas through PARTICIPATORY DEVELOPMENT.
- (4) Ensure projects produce long term SOCIAL AND ECONOMIC RESULTS.
- (5) Promote AFRICAN LED AND MANAGED field project support.
- (6) Achieve the highest levels of OPENNESS AND TRANSPARENCY.
- (7) Support and develop an equal opportunity, RESULTS DRIVEN STAFF that rewards hard work, dedication to the mission, and personal success.

USADF seeks a qualified individual to serve as a Country Program Coordinator (CPC) for its field office in Niamey, Niger.

The period of performance will be for One (1) Base Period, with Four (4) One year Option Periods. The exercise of option years will be at the discretion of the USADF.

### **2.0 GENERAL FUNCTION OF POSITION**

The purpose of the CPC is to assist the USADF in fulfilling its administrative oversight and program management responsibilities of grant agreements in Africa.

The CPC reports to the USADF Regional Director. The CPC manages the CPC office staff, which includes one Administrative Assistant and one (1) Driver.

### **3.0 SUMMARY OF WORK RESPONSIBILITIES**

**The CPC shall:**

Project Origination (30%): Support and document the receipt of grant applications, conduct the initial screening and sorting of applications, and present candidate applications to Regional Director (RD). In accordance with RD instructions, the CPC shall conduct site visits and prepare site visit reports of select applications. The CPC shall be responsible for maintaining correspondence with all applicants on the status of grant applications. Under the direction of the RD, the CPC shall orient new grantees to the USADF grant agreement. The CPC may also be asked to conduct outreach activities to publicize USADF's country program and encourage groups to apply.

Monitoring (40%): Use site visits to gather observations and grantee feedback and report to the RD on the effectiveness of the in-country partner's support of grantees. The CPC shall conduct at least one site visit to every grantee at least once every two years, or as determined by an annual monitoring plan established with the RD. The annual monitoring plan shall ensure that all grantees receive a site visit at

least once per year from the CPC, the RD, or other USADF/Washington program staff. The CPC shall provide a site visit report for each grantee site visit, as well as monthly CPC reports and bi-annual assessments of the partner's performance. In special cases site visits may also include remediation activities as directed by the RD. The CPC shall be familiar with the status of grantees by reviewing grantee quarterly reports and grantee disbursement requests on a timely basis.

Close-Out (15%): Support grant close-out activities and grant audit follow up activities as directed by the RD in accordance with the annual work plan developed by the RPD.

Management & Coordination (15%): Manage the CPC office. This includes managing the use of funds and maintaining accurate financial records, performing monthly bank reconciliations of the CPC bank account, and ensuring the proper use and maintenance of USADF assets. The CPC shall be responsible for the supervision of any support staff. The CPC shall assist in the coordination of USADF related visits and events associated with USADF/Washington staff. The CPC shall also, on a limited basis, interface with outside stakeholders on behalf of USADF as directed by the RPD.

### **3.1 PHYSICAL DEMANDS**

The work is generally sedentary and does not pose undue physical demands. During site visits, there may be some additional physical exertion including long periods of standing, walking over rough terrain, or the carrying of moderately heavy items (less than 50 pounds).

### **3.2 WORK ENVIRONMENT**

While in the country of assignment, the work is generally performed in an office environment. However, the position also requires travel throughout the countries of assignment, which may additionally involve numerous trips throughout Niger and in which special safety and/or security precautions, wearing of protective equipment and exposure to severe weather conditions may be required.

### **4.0 HOURS OF WORK AND OVERTIME**

The anticipated work week is 8:00-5:30, Monday – Friday. The workweek shall be for a total of forty (40) hours per week. From time to time, work in excess of these hours or outside the normal scheduled workweek may be requested by the COTR, PSS or other USADF staff.

Provided that it is requested, scheduled, and approved in advance by the COTR, such time worked may be compensated by time off. The CPC will request time off, and final approval of the request will be determined by the COTR. Compensatory time off must be approved in advance by the COTR.

The position will require the contractor to conduct site visits that will require the contractor to stay overnight. These trips may take place on weekends. The CPC will be reimbursed in local currency at actual expense and in accordance with USADF policy for lodging. An allowance will be provided for meals and incidental expenses (M&IE) at a rate in accordance with USADF policy. A copy of the USADF travel policy will be given to the CPC.

### **5.0 BENEFITS/ALLOWANCES**

Salary will be fixed and paid in local currency. The Base Period salary shall not exceed CFA 13,631,200 and will be adjusted accordingly at the time of contract award.

**a. Annual Increase:** An index of annual inflation, such as the International Monetary Fund (IMF) inflation index, and CPC performance shall be used as a guide for increases to annual salary for any option periods exercised.

**b. Vacation Leave:** After contract performance for a period of 90 calendar days, the CPC shall earn vacation leave at a rate of sixteen hours per month for a total of not-to-exceed one hundred ninety-

two hours per year. Salary payments while on annual leave will be based on 100% of all allowances normally paid each pay period. The CPC may accrue, accumulate, use and be paid when taking vacation leave.

The CPC shall make every effort to request and take vacation leave during the contract period when it is accrued. If it is not possible to take leave, a maximum of 192 hours of unused vacation leave may be carried over from one contract period to the next contract period.

The CPC will be paid for up to 192 hours of unused vacation leave at the expiration of the contract at the established rate per day based on the currently hourly rate. With written approval by the Contracting Officer's Technical Representative (COTR), the Contractor may be granted advance vacation leave not to exceed 192 hours annually.

**c. Sick Leave:** USADF will provide Sick Leave in accordance with Niger laws and regulations during the term of the contract.

**d. Holiday Leave:** The CPC will be entitled paid leave on the legal holidays observed by the USADF Field office in Niamey, Niger. The COTR will request any work on a holiday in writing in advance. In the unlikely event that the CPC is required to work on a holiday, the CPC will be compensated by time off, provided the work is approved by the COTR.

**e. Maternity/Paternity Leave:** USADF will provide maternity leave in accordance with the Niger laws and regulations during the term of the contract.

**f. Health Benefits:** The Government will reimburse *either* the purchase of a health insurance policy OR eighty percent of approved individual health-related expenditures for the contractor or members of his/her household, paid based on receipts/proof of purchase, and shall not exceed CFA 700,000 per contract year. Household members include spouse and recognized dependent children under the age of 25 with whom the Contractor is living.

**g. Severance Pay:** USADF will issue severance pay in accordance with Niger laws and regulations.

**h. Host Country Taxes:** USADF will provide payment of relevant taxes in the host country per local laws and regulations. Relevant employee contributions will be deducted from the CPC's salary payment.

The Contractor is obligated to pay any other taxes required by law.

## **6.0. CONTRACT TYPE**

The contract is firm fixed price (FFP).

## **7.0. CONTRACTOR / USADF RELATIONSHIP**

a. The Contractor acknowledges that this contract is important in support of USADF/ Niger operations and agrees that his/her duties shall be carried out in such a manner as to be fully commensurate with the responsibilities that this entails. Favorable relations between the Foundation and the Government and people of Niger require that the Contractor show respect for the conventions, customs, and institutions of Niger and not become involved in any illegal activity.

b. If the Contractor's conduct is not in accordance with 7.0.a, the contract may be terminated.

c. It shall be recognized at all times, the Contractor is engaged by contract and that he/she is not an employee or official of USADF. If, at any time during the effective period of this contract, the Contractor

should be appointed to a regular position in USADF or elsewhere in the service of the U.S. Government, this contract will automatically terminate.

(d) *Inspection/Acceptance*. The Contractor shall tender for acceptance only those items that conform to the requirements of this contract. The Government reserves the right to inspect or test any supplies or services that have been tendered for acceptance. The Government may require repair or replacement of nonconforming supplies or reperformance of nonconforming services at no increase in contract price. The Government must exercise its postacceptance rights—

(1) Within a reasonable period of time after the defect was discovered or should have been discovered; and

(2) Before any substantial change occurs in the condition of the item, unless the change is due to the defect in the item.

(e) *Excusable delays.* The Contractor shall be liable for default unless nonperformance is caused by an occurrence beyond the reasonable control of the Contractor and without its fault or negligence, such as acts of God or the public enemy, acts of the Government in either its sovereign or contractual capacity, fires, floods, epidemics, quarantine restrictions, strikes, unusually severe weather, and delays of common carriers. The Contractor shall notify the Contracting Officer in writing as soon as it is reasonably possible after the commencement of any excusable delay, setting forth the full particulars in connection therewith, shall remedy such occurrence with all reasonable dispatch, and shall promptly give written notice to the Contracting Officer of the cessation of such occurrence.

(f) *Termination for the Government's convenience.* The Government reserves the right to terminate this contract, or any part hereof, for its sole convenience. In the event of such termination, the Contractor shall immediately stop all work hereunder and shall immediately cause any and all of its suppliers and subcontractors to cease work. Subject to the terms of this contract, the Contractor shall be paid a percentage of the contract price reflecting the percentage of the work performed prior to the notice of termination, plus reasonable charges that the Contractor can demonstrate to the satisfaction of the Government, using its standard record keeping system, have resulted from the termination. The Contractor shall not be required to comply with the cost accounting standards or contract cost principles for this purpose. This paragraph does not give the Government any right to audit the Contractor's records. The Contractor shall not be paid for any work performed or costs incurred that reasonably could have been avoided.

(g) *Termination for cause.* The Government may terminate this contract, or any part hereof, for cause in the event of any default by the Contractor, or if the Contractor fails to comply with any contract terms and conditions, or fails to provide the Government, upon request, with adequate assurances of future performance. In the event of termination for cause, the Government shall not be liable to the Contractor for any amount for supplies or services not accepted, and the Contractor shall be liable to the Government for any and all rights and remedies provided by law. If it is determined that the Government improperly terminated this contract for default, such termination shall be deemed a termination for convenience.

(h) *Warranty.* The Contractor warrants and implies that the items delivered hereunder are merchantable and fit for use for the particular purpose described in this contract.

The Contractor shall submit monthly time sheets, with electronic bank account information and contract number included, to the COTR. Upon COTR approval of submitted time sheets, the CPC shall be paid electronically to their personal bank account in local currency converted from US dollars using the oanda.com exchange rates.

##### **OVERPAYMENTS**

In accordance with 52.212-4 section (i) 5 Overpayments: Accounts Receivable Conversion of Check Payments to EFT: If the Contractor sends the Government a check to remedy duplicate contract financing or an overpayment by the government, it will be converted into an electronic funds transfer (EFT). This means the Government will copy the check and use the account information on it to electronically debit the Contractor's account for the amount of the check. The debit from the Contractor's account will usually occur within 24 hours and will be shown on the regular account statement.

The Contractor will not receive the original check back. The Government will destroy the Contractor's original check, but will keep a copy of it. If the EFT cannot be processed for technical reasons, the Contractor authorizes the Government to process the copy in place of the original check.
